**British Academy of Audiology Response to Covid-19:** BAA strongly believes that maintaining access to good hearing for our patients/customers at this difficult time, particularly for those in self-isolation, self-distancing or key workers, is important. Guidance will depend on local regulations from employers and local guidance regarding PPE must be adhered to. Although we understand the nature of these difficult times, we asked that this matter be considered urgently as part of PHE response to Covid-19. Public Health England to create a guidance document. We are hoping to publish a document soon.
