Cancellations

Refunds for cancelled stands will only be made if the event is sold out. Every effort will be made to resell all stand space.

Stand allocation

Upon completion of the booking form, a BAA representative will contact you with additional information on availability of the requested stands. Every effort will be made to accommodate your preferences.

Payment

Full payment of the booked exhibition space and/ or sponsorship will need to be made within 30 days of invoicing or prior to the conference, whichever is sooner. Failure to pay for your stand or sponsorship will result in your company being refused entry to the event.

Stand restrictions for space-only stands

Any stand 4m or above in height must comply with the health and safety requirements for a complex temporary structure and must have a full risk assessment and structural plan approved by a qualified structural engineer. This is the responsibility of the exhibitor. To avoid this, the venue recommends keeping your stand under 3.9m.

When booking stand space, it is the responsibility of the exhibitor to ensure that there is adequate and suitable access to all services, including water and waste supply. We strongly recommend a site survey be undertaken if you plan a complex structure.

Please note that where the space opens onto a common corridor or walkway, the maximum height of any walling built must be no more than 1m. Where the space backs onto another stand, both parties will need to build dividing walls.

Floorplan

Detailed floor plans of your space only self-build stand must be submitted to the organisers 6 weeks prior to the event. The plans will then be forwarded to the venue for a health and safety check and compatibility check with adjacent stands.

Online Exhibitor Portal

The online exhibitor portal will be shared with all exhibitors in July and will allow exhibitors to order the necessary facilities. The portal will also include additional logistical information with regards to electricity, waste and water supply.
